All arrival times in Bath are approximately 6:30 to 7:30 p.m.

Please be aware that the bus will leave the departure points at the time listed and CANNOT wait for late arrivals. *Be sure to schedule your student for arrival at the airport, bus station or Amtrak with time to spare.*

The cost of the bus is \$45 for Portland, \$85 for Manchester or \$75 for other destinations, and will be automatically deducted from your student's bookstore account. This cost is per each way.

Space on the bus is limited so we require students to sign up in advance. If you call to add your student's name to the sign-up list, please be sure the student knows. There has been some confusion in the past because the parent signs the student up without his/her knowledge, and the student arranges another means of transportation. Once the student's name is on the list, the account will be charged, regardless of whether they actually board the bus or not. Thank you for your cooperation!

Unaccompanied Minors

Southwest Airlines

- Children ages five through eleven traveling without an accompanying passenger age 12 or older **MUST** travel as an unaccompanied minor on Southwest Airlines
- Southwest Airlines will charge a \$50.00 each way in addition to the air fare per child to travel.
- Any questions you can call 1-800-I-FLY-SWA

American Airlines

- Ages 8-14 can travel on any nonstop or direct flight through Charlotte, Washington Reagan, Dallas Forth Worth, New York, Los Angeles, Miami, Chicago, Philadelphia or Phoenix.
- Ages 8-14 have to use their unaccompanied minor service which charges a fee of \$150.00 each way
- Ages 15-17 don't have to use the unaccompanied minor service but it's still available to them.

United Airlines

- Children under the age of 15 years old need to use the unaccompanied minor service. Children age 16 & 17 are able to fly without it.
- There is an unaccompanied minor service charge and it can be paid at the time you book your flight.
- In addition to the information provided United Airlines may require information about the person bringing the child to the airport, and the information of the person meeting the child at his or her destination.
- When arriving at the airport, please visit the United check in counter. A United representative will advise you on whether you are able to take your child to the departure gate or if they will need to be escorted by a United representative.

JetBlue

- A child who has reached their 14th birthday and is traveling alone is no longer considered an unaccompanied minor. If you have questions about it can contact JetBlue at 1-800-538-2583
